

It guarantees the same mechanical and aesthetic performance as a normal virgin HDPE from petrochemical sources, but with the benefit of having obtained it from a vegetable source.

Bottle made of bio-based PE derived

from 100% sugar cane - recyclable.



Label made of bio-based PE derived from 100% sugar cane - recyclable.

Label size designed to facilitate recycling operations. Digital printing with silkscreen effect and use of a graphic software that ennobles the graphics making each label different from the others.
